Services Spotlight: Budget Reconciliation Policy Development, Analysis, and Advocacy

THE 2021 ENVIRONMENT

Congress and the Biden Administration are considering very significant policies in health care, including policies addressing COVID-19 relief and recovery, drug pricing, new government-run public options, expansions of Medicaid, changes in insurance benefits and affordability, changes to the taxation of health coverage, value-based care, digital health, and provider payments.

Given the narrow majorities in Congress, budget reconciliation has emerged as a likely vehicle for advancing several health care policies. Certain procedural advantages of budget reconciliation (mainly the 51-vote threshold in the Senate) enable changes to Medicare, Medicaid, and taxes on an expedited timeframe. This dynamic has resulted in budget reconciliation being a preferred means of recent Administrations in passing some types of sweeping legislative changes on a party-line basis. While budget reconciliation has certain procedural advantages, it is also fraught with complex rules and procedures that can make it very difficult to pass large pieces of policy legislation intact.



Budget Reconciliation Services

- **Congressional Intelligence:** Real-time information on committees of jurisdiction and leadership activities, including hearings, mark-ups, and analysis of proposed legislation.
- **Budget Reconciliation 101:** Presentations and targeted education materials to help stakeholders understand the budget reconciliation process and how it can impact their organization.
- Byrd Rule Analysis: Conduct detailed analysis of policy proposals for compliance with the Byrd Rule and other reconciliation rules and requirements. (The Byrd Rule specifies criteria under which a Senator can raise a point of order to strike content out of a reconciliation bill).
- **Policy Development:** Complete policy building, including policy creation, legislative text development, and collateral formation.
- Advocacy Strategy: Comprehensive advocacy planning to make sure messages cut through the noise on Capitol Hill, and stakeholders have the opportunity to impact the often "secretive" budget reconciliation process.
