

Why Use Budget Reconciliation?





# **Budget Reconciliation 101**





The budget reconciliation process was intended to facilitate the consideration and enactment of legislation that implements the policies assumed in the Congressional budget resolution.



The Congressional Budget Act establishes special procedures which govern consideration and passage of budget reconciliation legislation:

- Limits scope of legislation to changes to mandatory spending, revenue, and debt ceiling levels set forth in the budget.
- Sets timelines by which authorizing committees must pass legislation in line with reconciliation instructions.
- Allows for a simple majority vote in the Senate.
- Limits floor debate time in the Senate.



While originally created to force budgetary changes to help reduce the debt, the procedural elements of budget reconciliation have made it the preferred method for passing legislation on a party-line.




However, budget reconciliation also comes with significant political, procedural, and substantive limitations which can make the process complex for both policymakers and healthcare stakeholders.



Since 2010, reconciliation has been used seven times, all of which included health care provisions.

#### **GOP Policy Priorities:**

- "Must Pass" Items (debt ceiling)
- Expiring Tax Cut and Jobs Act
- Border Security/Immigration
- Department of Government Efficiency (DOGE)
- Reverse Biden Climate/Energy Policies



#### **Process Realities:**

- Byrd Rule
- Need to find offsets for spending increases
- Need for significant
   WH/House/Senate coordination
- Small vote margins = no room for error
  - o House +1
  - Senate +3

#### **Healthcare Impact:**

- Unlike 2017, structural health reforms are not a top GOP policy priority for reconciliation, but significant changes are still possible.
- Likely a source of funds/offsets to pay for other priorities.
- Some GOP priorities may only be done through reconciliation if they lack bipartisan support.

# **Step 1: Budget Resolution**



# Two potential sets of reconciliation instructions this year

#### **Reconciliation instructions** must identify:



FY26

which **authorizing committees** are required to pass reconciliation legislation;

the **dollar amount** of revenue or mandatory spending changes that must be achieved (or change to debt limit);

the **time period** in which the changes must be achieved (usually the 10-year budget window); and

by what **date**the reconciled authorizing committees are required to report their legislation.



# The Senate Byrd "Rule"





Any Senator who believes a provision violates the Byrd Rule can raise a Point of Order to have the provision stricken.

Any Senator can make a motion to waive the Byrd rule, which requires 60 votes.

# The Byrd Rule In Action: Individual Mandate





Repealing individual mandate violates Byrd Rule.

- Change in revenue.
- "Merely incidental" to larger policy change of getting rid of the mandate.
- Argued that the primary purpose of the individual mandate was to change behavior by compelling people to purchase insurance.



Reducing individual mandate penalty DOES NOT violate Byrd Rule.

- Change in revenue.
- No accompanying policy change.

Budget Reconciliation allows for the passage of legislation with only a **simple majority** in the Senate but is a complex process fraught with **procedural and political** peril.
